NOTICE OF INTENTION TO MAKE A GATING ORDER

SECTION 129A HIGHWAYS ACT 1980

ALLEYWAYS IN THE DISLEY AVENUE/BUXTON AVENUE AREA, CHORLTON PARK

Manchester City Council ("the Council") proposes for the purposes of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyways described in Schedule 1 to this Notice ("the Highways"). The Highways are shown as '1', '2' and '3' on the attached Order plan. The restrictions will apply at all times.

The Order will exempt any occupier adjoining or adjacent to the highways, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

Alternative routes for pedestrians are available by using the existing footways of Disley Avenue, Cavendish Road and Buxton Avenue as shown by dotted lines on the attached plan. A draft of the proposed Order is set out in Schedule 2 to this Notice.

Alleyways to be gated

Alleyway to the rear of 64 to 78 Cavendish Road with a length of 46 metres for its full width shown marked '1' on the plan.

Alleyway to the rear of 2 to 24 Disley Avenue with a length of 56 metres for its full width shown marked '2' on the plan.

Alleyway to the side of 24 Disley Avenue, continuing to the side of 23 Buxton Avenue with a length of 46 metres for its full width shown marked '3' on the plan.

SCHEDULE 2 DRAFT GATING ORDER - CITY OF MANCHESTER (ALLEYWAYS IN THE DISLEY AVENUE/BUXTON AVENUE AREA, CHORLTON PARK) GATING ORDER 2010

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

- 1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
- 2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
- 3. Barriers will be installed, operated and maintained at the sides of 2 Disley Avenue and 78 Cavendish Road, 1 Buxton Avenue and 64 Cavendish Road, 24 Disley Avenue and 23 Buxton Avenue. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
- 4. The alternative route which is available for use by pedestrians during the period the Highways are restricted are the existing footways of Disley Avenue, Cavendish Road and Buxton Avenue as shown by dotted lines on the plan annexed to this Order.
- 5. This Order shall take effect on the date hereof.
