1. <u>Introduction</u>

- 1.1 On 31 March 2006, Manchester published its first Children and Young People's Plan and in doing so met one of the new statutory requirements set out in the Children Act 2004. The plan is the single, strategic, overarching plan for all local services for children and young people. It sets out the agreed vision for children and young people in the area, and a set of top-level performance measures and targets and plans to achieve them. It does, however, remain a living document, and will need to keep pace with national and local developments, not least the outcome of the Joint Area Review.
- 1.2 A copy of the Plan has been circulated to Members. This report provides feedback to Members on how the comments made in the January Committee meeting informed the development of the Plan. It also summarises arrangements for communication and performance management.

2. Scrutiny Process

2.1 The Children and Young People's Overview and Scrutiny Committee considered a draft of the Children and Young People's Plan in January 2006. A number of comments and observations were made, which alongside the outcomes of other consultation processes, helped to inform the final version of the Plan.

2.2 Key examples include:

- The increased prominence given to mental health and its inclusion in the suite of the Plan's top level performance measures (as you will see from the Plan, the precise measure and baseline will be defined during the first year of the Plan);
- More information about the attainment of black and minority ethnic pupils, celebrating good comparative performance for some groups as well as areas for improvement;
- A greater emphasis on homelessness and a commitment to gain a better understanding of the causes of high levels of mobility and hence develop more effective interventions for prevention;
- A greater emphasis on the positive participation of children and young people, including volunteering – both volunteering and young people's perception of how much say they have are included in the suite of the Plan's top-level indicators;
- More value placed on the role of participation in play, sport, leisure and cultural activities – an 'enjoy' strategy is proposed.

3. Communication Process

- 3.1 The Government's basic minimum requirements for publicising the Plan have been met. The Plan has been published on the internet (www.manchester.gov.uk/education/cypp), copies are available in Public Libraries and a copy has been sent to those organisations that have a duty to cooperate under the Children Act 2004.
- 3.2 An executive summary of the Plan will be produced and made available to all those working in children's services. By June, more accessible versions will be made available for public circulation. The aim is to have a version for children and young people available in June for circulation via schools. Documents will be made available in the usual formats to ensure full access.

4. Performance Management

- 4.1 The Children's Board will ensure that the lines of accountability for all the top-level performance measures and Key Actions in the Plan are clearly in place. The Board will continue to assess and, where necessary, challenge performance.
- 4.2 Performance management processes will need to be further refined and integrated as the inter-agency governance arrangements are finalised. This will include taking advantage of the opportunities provided the Local Area Agreement to ensure improved outcomes for children and young people are a priority across the whole of the Manchester Partnership.

5. Conclusion

5.1 The Children and Young People's Plan provides an excellent basis for partners to deliver across a shared set of priorities, actions and outcomes.
