NOTICE OF INTENTION TO MAKE A GATING ORDER

SECTION 129A HIGHWAYS ACT 1980

**ALLEYWAY AT HILL STREET/HOPELEA STREET AREA OLD MOAT
GATING ORDER 2009**

Manchester City Council ("the Council") proposes for the purposes of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyway described in Schedule 1 to this Notice ("the Highway"). The Highway is shown edged in black on the attached plan. The restriction will apply at all times.


The Order will exempt any occupier of premises adjoining or adjacent to the highway, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

Alternative routes for pedestrians and vehicles are available by using the roads at front of Old Moat Lane, Hopelea Street and Hill Street as shown by dotted lines on the attached plan. A draft of the proposed Order is set out in Schedule 2 to this Notice.

A copy of the Council's statement of reasons for making the Order, a plan and other associated papers are available for inspection at Room 601, City Solicitor's Office, Town Hall, Manchester, M60 2LA during normal office hours. SCHEDULE 2

DRAFT GATING ORDER - SECTION 129A HIGHWAYS ACT 1980

CITY OF MANCHESTER (ALLEYWAY AT HILL STREET/HOPELEA STREET AREA OLD MOAT) GATING ORDER 2009

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyway ("the Highway") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highway or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highway.
3. Barriers will be installed, operated and maintained at each end of the Highway. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
4. The alternative routes for pedestrians and vehicular traffic which are available for use during the period the Highway is restricted are the roads to the front of Old Moat Lane, Hopelea Street and Hill Street as shown by dotted lines on the plan annexed to this Order.
5. This Order shall take effect on the date hereof.

SCHEDULE Alleyway to be gated

Alleyway to the rear of 8 to 12 Hopelea Street and continuing at side of 4 Old Moat Lane and 7 Hill Street for its full width and approximate length of 24 metres. Shown as 1 on the plan
