SECTION 129A HIGHWAYS ACT 1980 CITY OF MANCHESTER (CLEVELEYS AVENUE/WHALLEY AVENUE AREA, CHORLTON PARK) GATING ORDER 2010

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

- 1. Except as provided in Article 2 of this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
- 2. The restriction in Article 1 of this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
- 3. Barriers may be installed, operated and maintained at each end of the Highways. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
- 4. The alternative routes for pedestrians which are available for use during the period the Highways are restricted are;
 - 4.1 for the Highway marked '1' on the plan annexed to this Order the existing footway of Cleveleys Avenue, Whalley Avenue and the alleyway situated to the rear of 54-66 Sandy Lane and the alleyway situated to the side of 15/17 Cleveleys Avenue continuing to the side of 18/20 Whalley Avenue; and
 - 4.2 for the Highway marked '2' on the plan annexed to this Order the existing footway of Cleveleys Avenue, Whalley Avenue and the alleyway situated to the side of 31 Cleveleys Avenue continuing to the side of 38 Whalley Avenue and the alleyway situated to the side of 15/17 Cleveleys Avenue continuing to the side of 18/20 Whalley Avenue;

shown by dotted lines on the plan annexed to this Order.

5. This Order shall take effect on the 22nd day of February 2010.

SCHEDULE Alleyways to be gated

Alleyway situated to the rear 1-15 Cleveleys Avenue and 2-18 Whalley Avenue for the full length of 44 metres, and for the full width, shown marked '1' on the plan annexed to this Order.

Alleyway situated to the rear of 17-31 Cleveleys Avenue and 20-38 Whalley Avenue for the full length of 46 metres, and for the full width, shown marked '2' on the plan annexed to this Order.
