

SECTION 129A HIGHWAYS ACT 1980
CITY OF MANCHESTER (CAVENDISH AVENUE/MATLOCK AVENUE AREA,
CHORLTON PARK) GATING ORDER 2010

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 of this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order ("the Plan") and described in the Schedule to this Order at any time.
2. The restriction in Article 1 of this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
3. Barriers will be installed, operated and maintained at the junctions of the Highway marked '1' on the Plan with Matlock Avenue and Cavendish Avenue, at the junction of the Highway marked '3' on the Plan with Matlock Avenue, and at the junction of the Highway marked '4' on the Plan with Cavendish Avenue. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
4. The alternative routes for pedestrians which are available for use during the period the Highways are restricted are Matlock Avenue, Cavendish Road and Cavendish Avenue, as shown by dotted lines on the Plan.
5. This Order shall take effect on the 12 April 2010.

SCHEDULE

Alleyways to be gated

Alleyway situated to the rear of 36-48 Cavendish Road for the full length of 46 metres, and for the full width, shown marked '1' on the Plan;

Alleyway situated to the rear of 1-23 Cavendish Avenue/2-24 Matlock Avenue for the full length of 57 metres, and for the full width, shown marked '2' on the Plan;

Alleyway situated to the side of 24 Matlock Avenue and extending to the rear of 23 Cavendish Avenue for the full length of 24 metres, and for the full width, shown marked '3' on the Plan;


Alleyway situated to the side of 23 Cavendish Avenue for the full length of 22 metres, and for the full width, shown marked '4' on the Plan.
