SECTION 129A HIGHWAYS ACT 1980 CITY OF MANCHESTER (NUNEATON DRIVE AREA, MILES PLATTING/NEWTON HEATH) GATING ORDER 2010

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

- 1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown numbered 1, 2, 3, 4, 5 and 6 on the plan annexed to this Order and described in the Schedule to this Order at any time.
- 2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
- 3. Barriers will be installed, operated and maintained at the entrance of the highway adjoining 13 Crinan Walk, at each end of the highway adjoining 2 to 16 Crinan Walk and 2 to 16 Whitford Walk and the entrance of the highway adjoining 54 Farnborough Road. Neighbourhood Services, Private Sector Housing Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 245 7850.
- 4. The alternative routes for pedestrians and vehicular traffic which are available for use during the period the Highways are restricted are the roads adjoining 1 to 13 Crinan Walk, 2 to 14 Crinan Walk, 2 to 16 Whitford Walk and the highway linking Shenfield Walk to Winstanley Road as shown by dotted lines on the plan annexed to this Order.
- 5. This Order shall take effect on 9 August 2010.

SCHEDULE Alleyways to be gated

Alleyway to the side of 13 Crinan Walk with a length of 24 metres for its full width shown marked '1' on the plan.

Alleyway adjoining 1 to 23 Crinan Walk with a length of 64 metres for its full width shown marked '2' on the plan.

Alleyway adjoining 2 to 16 Crinan Walk with a length of 47 metres for its full width shown marked '3' on the plan.

Alleyway to the rear of 2 to 14 Nuneaton Drive with a length of 39 metres for its full width shown marked '4' on the plan.

Alleyway to the rear of 42 to 54 Farnborough Road with a length of 39 metres for its full width shown marked '5' on the plan.

Alleyway adjoining 2 to 16 Whitford Walk with a length of 43 metres for its full width shown marked '6' on the plan.
