NOTICE OF INTENTION TO MAKE A GATING ORDER
SECTION 129A HIGHWAYS ACT 1980
ALLEYWAYS AT GARFIELD AVENUE AND BROOM LANE, GORTON SOUTH GATING
ORDER 2010

Manchester City Council ("the Council") proposes for the purposes of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyways described in Schedule 1 to this Notice ("the Highways"). The Highways are shown edged in black on the Order plan. The restriction will apply at all times.


The Order will exempt any occupier of premises adjoining or adjacent to the Highways, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

Alternative routes for pedestrians and vehicles are available by using the existing highways of Garfield Avenue, Chapel Street, Broom Lane and Carnegie Avenue as shown by dotted lines on the attached plan. A draft of the proposed Order is set out in Schedule 2 to this Notice.

A copy of the Council's statement of reasons for making the Order, a plan and other associated papers are available for inspection at Room 601, City Solicitor's Office, Town Hall, Manchester, M60 2LA during normal office hours. SCHEDULE 2
DRAFT GATING ORDER - SECTION 129A HIGHWAYS ACT 1980
CITY OF MANCHESTER (GARFIELD AVENUE AND BROOM LANE, GORTON SOUTH)
GATING ORDER 2010

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or

duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.

3. Barriers will be installed, operated and maintained at the side of 10, 22,34 Garfield Avenue, 187 and 211 Broom Lane and at rear of 2 and 46 Garfield Avenue. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
4. The alternative routes for pedestrians and vehicular traffic which are available for use during the period the Highways are restricted are the roads to the front of Garfield Avenue, Chapel Street, Broom Lane and Carnegie Avenue as shown by dotted lines on the plan annexed to this Order.
5. This Order shall take effect on the date hereof.

Alleyway to side of 10/12 Garfield Avenue for its full width and approximate length of 18 metres. Shown as 1 on the plan.

Alleyway to side of 22/24 Garfield Avenue for its full width and approximate length of 18 metres . Shown as 2 on the plan.

Alleyway to side of 34/36 Garfield Avenue for its full width and approximate length of 18 metres. Shown as 3 on the plan.

Alleyway to rear of 2 to 46 Garfield Avenue and 165 to 231 Broom Lane for its full width and approximate length of 157 metres. Shown as 4 on the plan.

Alleyway to side of 187/189 Broom Lane for its full width and approximate length of 19 metres . Shown as 5 on the plan.

Alleyway to side of 211/213 Broom Lane for its full width and approximate length of 19 metres. Shown as 6 on the plan.
