

SECTION 129A HIGHWAYS ACT 1980
CITY OF MANCHESTER (DUNCAN ROAD/CLITHEROE ROAD AREA,
LONGSIGHT) GATING ORDER 2010

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 of this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black and numbered 1, 2, 3 and 4 on the plan annexed to this Order ("the Plan") and described in the Schedule to this Order at any time.
2. The restriction in Article 1 of this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
3. Barriers will be installed, operated and maintained at each of the following locations :- to the side of each of 44 Duncan Road, 72 Duncan Road, 53 Clitheroe Road and 93 Clitheroe Road and at the south end of the Highway marked '1' on the Plan. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
4. The alternative routes for pedestrians and vehicles which are available for use during the period the Highways are restricted are Beresford Road, Duncan Road, Clitheroe Road and Hamilton Road as shown by dotted lines on the Plan.
5. This Order shall take effect on the 23rd November 2010.

SCHEDULE
Alleyways to be gated

Alleyway situated to the side of 92 Duncan Road continuing to the side of 93 Clitheroe Road for the full length of 46 metres, and for the full width, shown marked '1' on the Plan;

Alleyway situated to the rear of 44-92 Duncan Road and 53-93 Clitheroe Road for the full length of 153 metres, and for the full width, shown marked '2' on the Plan;

Alleyway situated to the side of 72/74 Duncan Road for the full length of 21 metres, and for the full width, shown marked '3' on the Plan;


Alleyway situated to the rear of 74-88 Hamilton Road for the full length of 47 metres, and for the full width, shown marked '4' on the Plan.
