

**SECTION 129A HIGHWAYS ACT 1980**  
**CITY OF MANCHESTER (KINGSHILL ROAD/IVYGREEN ROAD AREA,**  
**CHORLTON) GATING ORDER 2011**

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 of this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order ("the Plan") and described in the Schedule to this Order at any time.
2. The restriction in Article 1 of this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
3. Barriers will be installed, operated and maintained at each of the following locations; at the north end of the Highway marked '4' on the Plan, at the south end of the Highway marked '3' on the Plan and set back so as to be in line with the front corner of the gable end at each of 1 Vicars Road, 66 Kingshill Road and 38 Kingshill Road. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 4904.
4. The alternative routes for pedestrians and vehicles which are available for use during the period the Highways are restricted are Kingshill Road, Ivygreen Road, Vicars Road and the alleyway located to the side of 16/18 Kingshill Road continuing to the side of 17/19 Vicars Road as shown by dotted lines on the Plan.
5. This Order shall take effect on the 21<sup>st</sup> February 2011.

**SCHEDULE**

**Alleyways to be gated**

Alleyway situated to the side of 38/40 Kingshill Road for the full length of 20 metres, and for the full width, shown marked '1' on the Plan;

Alleyway situated to the side of 66/68 Kingshill Road for the full length of 20 metres, and for the full width, shown marked '2' on the Plan;

Alleyway situated to the rear of 18-66 Kingshill Road and the rear of 19-49 Vicars Road, for the full length of 125 metres, and for the full width, shown marked '3' on the Plan;

Alleyway situated to the rear of 2-16 Kingshill Road and the rear of 1-17 Vicars Road for the full length of 36 metres, and for the full width, shown marked '4' on the Plan;

Alleyway situated to the rear of 66-72 Ivygreen Road for the full length of 20 metres, and for the full width, shown marked '5' on the Plan.
