

SECTION 129A HIGHWAYS ACT 1980
CITY OF MANCHESTER (LINCOLN AVENUE, LEVENSHULME) GATING
ORDER 2011

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 of this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order ("the Plan") and described in the Schedule to this Order at any time.
2. The restriction in Article 1 of this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
3. Barriers will be installed, operated and maintained at the west end of the Highways marked '1' and '2' on the Plan, the east end of the Highways marked '5' and '6' on the Plan, at each end of the Highway marked '3' on the Plan and at the south end of the Highway marked '4' on the Plan. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 245 7850.
4. The alternative route for pedestrians which is available for use during the period the Highways are restricted are the footways of Lincoln Avenue, Chapel Street, Garfield Avenue and Carnegie Avenue, as shown by dotted lines on the Plan.
5. This Order shall take effect on the 28 February 2011.

SCHEDULE

Alleyways to be gated

Alleyway situated to the side of 14/16 Lincoln Avenue for the full length of 17 metres, and for the full width, shown marked '1' on the Plan;

Alleyway situated to the side of 26/28 Lincoln Avenue for the full length of 18 metres, and for the full width, shown marked '2' on the Plan;

Alleyway situated to the rear of 1-11 Carnegie Avenue for the full length of 42 metres, and for the full width, shown marked '3' on the Plan;

Alleyway situated to the rear of 2-58 Lincoln Avenue and the rear of 1-59 Garfield Avenue, for the full length of 150 metres, and for the full width, shown marked '4' on the Plan;

Alleyway situated to the side of 5/7 Garfield Avenue for the full length of 19 metres, and for the full width, shown marked '5' on the Plan;


Alleyway situated to the side of 21/23 Garfield Avenue for the full length of 19 metres, and for the full width, shown marked '6' on the Plan.
