

SECTION 129A HIGHWAYS ACT 1980
CITY OF MANCHESTER (ALLEYWAYS IN THE PROVIS ROAD AREA,
CHORLTON) GATING ORDER 2011

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
3. Barriers will be installed, operated and maintained at the ends of the Highways. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 245 7850.
4. An alternative route for pedestrians and vehicles is available by using the existing highways of Higson Avenue, Belwood Road, Provis Road and Copgrove Road as shown by dotted lines on the Order plan.
5. This Order shall take effect on the 15th day of August 2011..

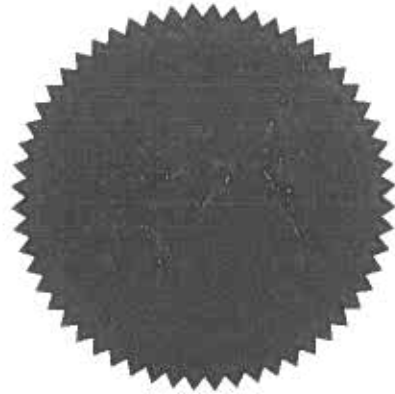
SCHEDULE

Alleyways to be gated

- 1) The alleyway situated to the side of 19 – 21 Higson Avenue over its full length of 20 metres and for its full width. Shown marked '1' and edged in black on the Order plan.
- 2) The alleyway situated to the side of 35 – 37 Higson Avenue over its full length of 20 metres and for its full width. Shown marked '2' and edged in black on the Order plan.
- 3) The alleyway situated to the rear of 1 – 51 Higson Avenue and the rear of 2 – 52 Provis Road over its full length of 119 metres and for its full width. Shown marked '3' and edged in black on the Order plan.
- 4) The alleyway situated to the side of 20 – 22 Provis Road over its full length of 20 metres and for its full width. Shown marked '4' and edged in black on the Order plan.
- 5) The alleyway situated to the side of 36 – 38 Provis Road over its full length of 20 metres and for its full width. Shown marked '5' and edged in black on the Order plan.
