NOTICE OF INTENTION TO MAKE A GATING ORDER

SECTION 129A HIGHWAYS ACT 1980

**CITY OF MANCHESTER (GREAT SOUTHERN STREET AREA, MOSS SIDE) GATING
ORDER 2012**

Manchester City Council ("the Council") proposes for the purposes of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyways described in Schedule 1 to this Notice ("the Highways"). The Highways are shown marked '1' and '2' on the attached Order plan. The restrictions will apply at all times.


The Order will exempt any occupier adjoining or adjacent to the highways, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

Alternative routes for pedestrians are available by using the existing footways of Dunworth Street, Rawcliffe Street, Seedley Street, Kippax Street and Crofton Street as shown by dotted lines on the attached plan. A draft of the proposed Order is set out in Schedule 2 to this Notice.

A copy of the Council's statement of reasons for making the Order, a plan and other associated papers are available for inspection at Room 601, City Solicitor's Office, Town Hall, Manchester, M60 2LA during normal office hours. Alleyways to be gated

Alleyway situated to the rear of 42 Seedley Street / side of 48 Crofton Street to the rear of 2 Seedley Street / side of 49 Kippax Street with an approximate length of 92 metres for its full width shown marked '1' on the Order plan

Alleyway situated to the side of 50 and 52 Crofton Street to the side of 51 and 53 Kippax Street with an approximate length of 92 metres for its full width shown marked '2' on the Order plan.

SCHEDULE 2

DRAFT GATING ORDER - SECTION 129A HIGHWAYS ACT 1980 **CITY OF MANCHESTER (ALLEYWAYS IN THE GREAT SOUTHERN STREET AREA,** **MOSS SIDE) GATING ORDER 2012**

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown hatched and edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.
3. Barriers will be installed, operated and maintained at the rear of 42 Seedley Street and side of 48 Crofton Street, at the rear of 2 Seedley Street and side of 49 Kippax Street, in between 50 and 52 Crofton Street and in between 51 and 53 Kippax Street. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 245 7850.
4. The alternative routes which are available for use by pedestrians during the period the Highways are restricted are the existing footways of Dunworth Street, Rawcliffe Street, Seedley Street, Kippax Street and Crofton Street as shown by dotted lines on the plan annexed to this Order.
