NOTICE OF INTENTION TO MAKE A GATING ORDER
SECTION 129A HIGHWAYS ACT 1980
ACRES ROAD AREA, CHORLTON
GATING ORDER 2012

Manchester City Council ("the Council") proposes for the purposes of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyways described in Schedule 1 to this Notice ("the Highways"). The Highways are shown as '1', '2', '3', '4', '5' and '6' on the Order plan. The restriction will apply at all times.


The Order will exempt any occupier of premises adjoining or adjacent to the Highways, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

Alternative routes for pedestrians are available by using the existing footways of Acres Road, Beech Road, the alleyway to the rear of 56 to 60 Beech Road and the alleyway to the side of 54/56 Beech Road as shown by dotted lines on the Order plan. A draft of the proposed Order is set out in Schedule 2 to this Notice.

SCHEDULE 1
Alleyways to be gated

1. Alleyway situated to the side of 5 Acres Road for length of 16.5 metres to the rear boundary of Our Lady and St John Parish Centre and for its full width as shown marked '1' on the plan.

2. Alleyway situated to the side of 25 and 27 Acres Road for a length of 13 metres and for its full width as shown marked '2' on the plan.

3. Alleyway situated to the side of 43 and 45 Acres Road for a length of 13 metres and for its full width as shown marked '3' on the plan.
4. Alleyway situated to the side of 51 and 53 Acres Road for a length of 13 metres and with a width varying between 1.5 metres and 3 metres as shown marked '4' on the plan.
5. Alleyway situated to the side of 61 and 63 Acres Road for a length of 13 metres and for its full width as shown marked '5' on the plan.
6. Alleyway located to the rear of 5 -67 Acres Road for a length of 152 metres and for its full width as shown marked '6' on the plan.

SCHEDULE 2

DRAFT GATING ORDER - SECTION 129A HIGHWAYS ACT 1980 **CITY OF MANCHESTER (ACRES ROAD AREA, CHORLTON)** **GATING ORDER 2012**

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

1. Except as provided in Article 2 to this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black on the plan annexed to this Order and described in the Schedule to this Order at any time.
2. The restriction in Article 1 to this Order shall not apply to any occupier of premises adjoining or adjacent to the Highways or to any person engaged on Council business, to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways
3. Barriers will be installed, operated and maintained to the side of 5 Acres Road, the side of 25/27 Acres Road, the side of 43/45 Acres Road, the side of 51/53 Acres Road, the side of 61/63 Acres Road and adjacent to the rear boundary of 67 Acres Road. Private Sector Housing, Central Operations Division is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 245 7850.
4. The alternative routes for pedestrians and vehicular traffic which are available for use during the period the Highways are restricted are the existing footways of Acres Road, Beech Road, the alleyway to the rear of 56 to 60

Beech Road and the alleyway to the side of 54/56 Beech Road as shown by dotted lines on the plan annexed to this Order.

5. This Order shall take effect on the date hereof.
