NOTICE OF INTENTION TO MAKE A GATING ORDER

SECTION 129A HIGHWAYS ACT 1980

ALLEYWAYS IN THE ARROWFIELD ROAD AREA, CHORLTON

Manchester City Council ("the Council") proposes for the purpose of reducing crime and antisocial behaviour to make an Order preventing anyone, other than those persons specified in the Order, from using the alleyways ("the Highways") described in the Schedule to the Order. A draft of the proposed Order is set out in the Schedule to this Notice. The Highways are shown edged black and marked '1', '2', '3', '4' and '5' on the Order plan. The restriction will apply at all times.

The Order will exempt any occupier of premises adjoining or adjacent to the Highways, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers from the restriction.

Alternative routes are available by using the existing highways of Arrowfield Road, Arrowfield Drive, Cressfield Way, Bullfinch Walk, Pheasant Drive and the paths to the rear of 6 Arrowfield Road, to the side of 10 Pheasant Drive and to the rear of 1-5 Bullfinch Walk as shown by the broken black lines on the Order plan.

<u>DRAFT GATING ORDER – CITY OF MANCHESTER (ARROWFIELD ROAD AREA, CHORLTON) GATING ORDER 2013</u>

The Council of the City of Manchester in exercise of its power under Section 129A (1) of the Highways Act 1980 ("the Act") and of all other enabling powers being satisfied that the conditions set out in Section 129A (3) of the Act have been met hereby makes the following Order:

- 1. Except as provided in Article 2 of this Order no person shall use the public right of way over the alleyways ("the Highways") shown edged black and numbered 1 5 on the plan annexed to this Order and described in the Schedule to this Order at any time.
- 2. The restriction in Article 1 of this Order shall not apply to any person who lives in premises adjoining the Highways or to any person engaged on Council business, or to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to

any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Highways.

- 3. Barriers will be installed, operated and maintained at each end of the Highways. Neighbourhood Services, Escalated Enforcement Team is responsible for maintaining and operating any barriers. Their contact telephone number is 0161 234 1375.
- 4. The alternative routes which are available for use during the period the Highways are restricted are the highways of Arrowfield Road, Arrowfield Drive, Cressfield Way Bullfinch Walk and Pheasant Drive and the paths to the rear of 6 Arrowfield Road, the side of 10 Pheasant Drive and to the rear of 1 5 Bullfinch Walk as shown by the broken black lines on the plan annexed to this Order.
- 5. This Order shall take effect on the date thereof.

SCHEDULE Alleyways to be gated

Alleyway located to the rear of 8-14 Arrowfield Road for an approximate length of 24 metres and for its full width as shown marked '1' on the plan.

Alleyway located to the rear of 22-24 Pheasant Drive for an approximate length of 17 metres and for its full width as shown marked '2' on the plan.

Alleyway located to the rear of 30-36 Pheasant Drive and for an approximate distance of 27 metres and for its full width as shown marked '3' on the plan.

Alleyway located to the side of 21 Bullfinch Walk and the side of 38 Pheasant Drive for an approximate length of 15 metres and for its full width as shown marked '4' on the plan.

Alleyway located to the rear of 1-5 Bullfinch Walk and the side of 8 Pheasant Drive for an approximate length of 20 metres and for its full width as shown marked '5' on the plan
