MANCHESTER CITY COUNCIL

The Council intends to make the CITY OF MANCHESTER (MYTHORN WALK, NEWTON HEATH) PUBLIC SPACES PROTECTION ORDER 2016._("the Order") under ss. 59 and 64 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act"),to prohibit the occurrence of the specified anti-social activities in the Restricted Area while the Order is in force.

Restricted Area: the area described in Schedule 2 to the Draft Order and shown coloured black on the plan annexed to the draft Order ("the Order Plan").

The Activities: Criminal damage, anti-social behaviour including – drug taking, playing loud music, set fire to bins, abusive behaviour, congregating beneath the location of the floating bedroom of 7 Mythorn Walk

The Restriction: Subject to the exemptions specified below, the Order will prohibit persons from being in the Restricted Area at all times. Barriers will be installed, operated and maintained at the locations shown on the Order Plan. It is intended that the Order will be in effect for 3 years, subject to any variation or extension of its duration.

Exemptions: The prohibition of being in the Restricted Area does not apply to the occupiers of premises adjoining or adjacent to the Restricted Area, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers.

Alternative Routes: for pedestrians are the routes shown in blue dashed lines on the Order Plan.

SCHEDULE Draft Order

CITY OF MANCHESTER (MYTHORN WALK, NEWTON HEATH) PUBLIC SPACES PROTECTION ORDER 2016

The Council of the City of Manchester ('the Council') in exercise of its power under Sections 59 and 64 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") and of all other enabling powers, having had regard to the matters specified in sections 64 and 72 of the Act and having undertaken the necessary consultation, publicity and notification, hereby makes the following Order in order to prohibit the occurrence of the activities ('the Activities) described in Schedule 1 to the Order, within the Public Place comprising a highway within the Council's area ('the Restricted Area'), as follows:

The Restriction

1. Except as provided in Article 2 of this Order no person shall be in the Restricted Area at any time shown coloured black on the plan annexed to this Order ('the Order Plan') and described in Schedule 2 to this Order

Exemptions

2. Subject to Article 3, the prohibition provided by Article 1 of this Order shall not apply to any occupiers of premises adjoining or adjacent to the Restricted Area or to any person engaged on Council business, to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Restricted Area.

Contravention

3. It is an offence for a person without reasonable excuse to contravene the restriction provided by Article 1 of this Order. A person guilty of an offence is liable on summary conviction to a fine not exceeding level 3 on the standard level.

Alternative Route

4. The alternative route for pedestrians while this Order is in effect are the street footways of Harmer Close and Mythorn Walk shown by blue dashed lines on the Order Plan.

Barriers

5. Barriers will be installed, operated and maintained at the locations shown on the Order Plan.

Duration

6. The Order shall take effect on ... (insert date) and has effect for[3 years] until the day of(insert date) subject to any variation or extension of the Order.

Citation

7. The Order shall be cited as CITY OF MANCHESTER (MYTHORN WALK, NEWTON HEATH) PUBLIC SPACES PROTECTION ORDER 2016.
