

MANCHESTER CITY COUNCIL

The Council intends to make the **Manchester City Council (Eccleshall Street, Oldfield Street and Babbington Street, Clayton) Public Space Protection Order 2016** (“the Order”) under ss. 59 and 64 of the Anti-Social Behaviour, Crime and Policing Act 2014 (“the Act”) to prohibit the occurrence of the specified anti-social activities in the Restricted Area while the Order is in force.

Restricted Area: the area described in Schedule 1 to the draft Order and shown hatched black on the plan annexed to the draft Order (“the Order Plan”).

Nature of prohibition (i) Subject to the exemptions specified below, no person shall be in the Restricted Area and (ii) No person in the Restricted Area shall engage in the prohibited activities that are specified in Schedule 2 to the draft Order.

Duration of prohibition : at all times


Exemptions: the prohibition of being in the Restricted Area does not apply to the occupiers of premises adjoining or adjacent to the Restricted Area, any person engaged on Council business, emergency services personnel, statutory undertakers and utility providers.

Alternative Route: available for vehicles is along Ashton New Road to Clayton Lane as shown by a dotted line on the Order Plan.

Schedule Draft Order

CITY OF MANCHESTER (ECCLESHALL STREET, OLDFIELD STREET AND
BABBINGTON STREET, CLAYTON) PUBLIC SPACES PROTECTION ORDER
2016

The Council of the City of Manchester (‘the Council’) in exercise of its power under Sections 59 and 64 of the Anti-Social Behaviour, Crime and Policing Act 2014 (‘the Act’) and of all other enabling powers, having had regard to the matters specified in sections 64 and 72 of the Act and having undertaken the necessary consultation, publicity and notification, hereby makes the following Order to prohibit the occurrence of the activities (‘the Activities’) described in Schedule 2 to the Order, within the Public Place comprising a highway within the Council’s area (‘the Restricted Area’), as follows:

1. Except as provided in Article 2 of this Order no person shall be in the Restricted Area shown edged red on the plan annexed to this Order ('the Order Plan') and described in Schedule 1 to this Order at any time.
2. The prohibition provided by Article 1 of this Order shall not apply to any occupiers of premises adjoining or adjacent to the Restricted Area or to any person engaged on Council business, to any police, ambulance or fire service personnel acting in pursuance of statutory powers or duties or to any statutory undertaker, gas, electricity, water or communications provider requiring access to their apparatus situated in the Restricted Area.
3. No person in the Restricted Area shall engage in the Activities specified in Schedule 2 to this Order.
4. It is an offence for a person without reasonable excuse to do anything that the person is prohibited from doing by Article 1 and Article 3 of this Order.
5. Barriers will be installed, operated and maintained at the locations shown on the Order Plan. Corporate Services, Manchester Contracts, Hooper Street Depot, Block C, Manchester M12 6LA are responsible for maintaining and operating any barriers. Their contact telephone number is 0161 908 5866.
6. The alternative route for vehicular traffic while this Order is in effect is via Ashton New Road to Clayton Lane as shown by dotted lines on the Order Plan.
7. The Order shall be cited as the **(Eccleshall Street, Oldfield Street and Babbington Street, Clayton) Public Space Protection Order 2015**. The Order shall take effect on ... *(insert date)* and has effect for[3 years] until the day of *(insert date)* subject to any variation or extension of the Order.
