**ADMISSION POLICY 2023-24**

**Mission Statement**

**The Divine Mercy is a Roman Catholic Primary School which reflects the teachings of Jesus Christ in the Gospels.**

**With Jesus in our hearts and the children at the centre we welcome and reach out to our diverse community in the Christian spirit.**

**We value and nurture everyone, inspiring them to reach their full potential through the education and formation our school brings about.**

The Divine Mercy RC Primary School is a Catholic School in the trusteeship of the Diocese of Salford. It is maintained by Manchester Local Authority and is a voluntary aided School. The Governing Body is the Admissions Authority and is responsible for taking all decisions on applications for admissions. The co-ordination of admissions arrangements is undertaken by the Local Authority.

For the school year commencing 2023-24 the Governing Body's planned admission number is 60.

The school's role is to participate in the mission of the Catholic Church by providing a curriculum, including Catholic religious education and worship, which will help children to grow in their understanding of the Good News and in the practice of their faith. The school will help the children develop fully as human beings and prepare them to undertake their responsibilities as Catholics in society. The school requires all parents applying for a place here to understand and respect this ethos and its importance to the school community. This does not affect the rights of parents who are not of the Catholic faith to apply for a place here.

Admissions to the school will be determined by the Governing Body. Parents must complete a Local Authority Preference Form or apply online via the website [www.manchester.gov.uk/info/500321/primary\\_school\\_admissions](http://www.manchester.gov.uk/info/500321/primary_school_admissions). If there are fewer than 60 applications, all applicants will be offered places. If there are more applications than the number of places available, the following oversubscription criteria will be applied:

1. Baptised Catholic Looked After Children and baptised Catholic previously Looked After Children. (Previously Looked After Children are children who were looked after, but ceased to be so because they were adopted or became subject to a residence order or special guardianship order.)
2. Children with an exceptional social, medical, educational or religious need which can be best met, or only met at this school;\*
3. Baptised Catholic children who have a sibling in the school at the time of admission.
4. Baptised Catholic children resident in the parishes of English Martyrs or St Joseph's and St Edward's.
5. Baptised Catholic Children of members of staff who have been employed at the school for two or more years at the time the application is made.
6. Other Baptised Catholic Children.
7. Looked After Children and previously Looked After Children.
8. Other children who have a sibling in the school at the time of admission.
9. All remaining applicants.

\*Exceptional needs of this kind will occur very rarely. It is strongly recommended that a written application is submitted in advance of the normal admissions timetable.

If it is not possible to offer places for all applications within any criterion above, priority will be given to those living closest to the school measured by the method used by the local authority. In the event of distances being the same for 2 or more applicants, places will be allocated by method used by the local authority.

## Notes for Applicants:

- a. The Governing Body is the admissions authority. The Admissions Committee is comprised of the following governors: Chair of Governors, Parish Priest and Headteacher.
- b. All applications will be considered at the same time and after the closing date for admissions which is 15 January 2023. Applications received after this date will be **treated as a late application** and will not be considered until **after** the main allocation of places has taken place.
- c. Parents should check carefully whether they are resident within the parish boundaries of English Martyrs or St Joseph's and St Edward's.
- d. All applicants resident in the parishes of English Martyrs, St Josephs and St Edward's will be required to provide proof of address, by supplying an original, up-to-date, utility bill or family credit book.
- e. A Looked After Child is a child who is (a) in the care of a Local Authority, or (b) being provided with accommodation by a Local Authority in the exercise of their Social Services functions (under section 22(1) of the Children Act 1989). A previously Looked After Child is one who immediately moved on from that status after becoming subject to an adoption, residence or special guardianship order.  
For a child to be considered as a Catholic evidence of a Catholic Baptism or reception into the Catholic Church is required. Written evidence of reception into the Catholic Church can be obtained by referring to the Register of Receptions, or in some cases a sub-section of the Baptismal Registers of the Church in which the Rite of Reception took place. If, for example, a child has been baptised in the Church of England and the parents are subsequently admitted to the Catholic Church through the RCIA programme, the child must also be admitted to the Church by the Rite of Reception.
- f. The Governing Board will require written evidence in the form of a Certificate of Reception before applications for school places can be considered for categories of 'Baptised Catholics'. A Certificate of Reception is to include full name, date of birth, date of reception and parent(s) name(s). The certificate must also show that it is copied from the records kept by the place of reception.
- g. Those who have difficulty obtaining written evidence of baptism for a good reason, may still be considered as baptised Catholics but only after they have been referred to the parish priest who, after consulting with the Salford diocesan authority will decide how the question of baptism is to be resolved and how written evidence is to be produced in accordance with the law of the Church.
- h. It is the duty of governors to comply with class size limits at Key Stage One. This means that the school cannot operate classes in Key Stage One of more than 30 children.  
  
Special Needs
- i. If a child has a statement of special needs naming a specific school there is a duty for the school to admit the child.
- j. If in any criteria category there are more applications than places available, priority will be given on the basis of proximity to the school. This will be determined by the straight-line distance from the front entrance of the school to home of the child concerned. *Distance is to be measured in a straight line from the centre point of the child's permanent home address to the centre point of the school as defined by the Ordnance Survey, the national mapping agency, using the Local Authority's computerised measuring system, with those living closer to the school receiving the higher priority.*

- k. Where a child lives with parents with shared responsibility, each part of the week, the 'home' address will be determined as being where the child resides for the majority of the school week.
- l. Home Address is considered to be the address where the child normally lives. Where care is split and a child moves between two addresses, the household in receipt of the child benefit would normally be the address used but the admission authority body reserves the right to request other evidence as fit the individual circumstance. Applicants should not state the address of another relative or person who has daily care of the child.
- m. 'Sibling' is defined in these arrangements as full, half or step brothers and sisters, adopted and foster brothers and sisters who are living at the same address and are part of the same family unit. This does not include cousins or other family relationships.
- n. A waiting list for children who have not been offered a place will be kept and will be ranked according to the Admission Criteria. The waiting list does not consider the date the application was received or the length of time a child's name has been on the waiting list. This means that a child's position on the list may change if another applicant is refused a place and their child has higher priority in the admissions criteria.
- o. For 'In Year' applications received outside the normal admissions round, if places are available they will be offered to those who apply. If there are places available but more applicants than places then the published oversubscription criteria will be applied.
- p. If an application for admission has been turned down by the Governing Board, parents may appeal to an Independent Appeals Panel. Parents must be allowed at least twenty school days from the date of notification that their application was unsuccessful to submit that appeal. Parents must give reasons for appealing in writing and the decision of the Appeals Panel is binding on the Governors.
- q. The Governing Body reserve the right to withdraw the offer of a school place where false evidence is received in relation to the application.
- r. It is the duty of governors to comply with regulations on class size limits for children aged between rising five and seven. The Governing Board may exceed the regulations for twins and children from multiple births where one of the children is the 30<sup>th</sup> child admitted. This also applies to in-year applicants who are Looked After/previously Looked After Children of UK service personnel or children who move into the area for whom there is no other school available within a reasonable distance.
