Guidelines for Licensees

### Introduction

The Manchester bee is one of the best-known symbols of Manchester and has been an emblem for the city for over 150 years. In 1842, the bee was officially incorporated into the Manchester coat of arms. Now you can see the bee all over the city.

Manchester's bee is a worker bee, reflecting a city made by its workers – the people of Manchester. For many Mancunians, the worker bee represents both hard work and working together, and it has come to represent the sense of unity in our great city.

Manchester City Council holds the registered trade marks for various iterations of the bee. This document outlines the style guide for use of the Manchester worker bee logo (the mark) and aims to ensure a recognisable, consistent and high-quality standard across printed and digital channels. It serves as a reference tool that will help maintain consistency by demonstrating how the mark should be reproduced.

As someone who has been licensed to use the mark, you have a responsibility to maintain the credibility of the Manchester bee brand and protect the mark's reputation and integrity by always applying these guidelines.



## Part 1: The Manchester bee

The mark must always be reproduced from master copy artwork to ensure consistency and quality.

The logo must always be reproduced from master copy artwork to ensure consistency and quality.

Any use of the worker bee mark must be in accordance with the terms of the licence granted for such use.



## Colour variation examples

We have various iterations of the mark registered, including with transparent or grey wings.

Spot, CMYK, RGB and mono versions of the mark are available in various formats on request.



### What to do

Don't alter the mark's appearance. For example:

- ✓ Keep it in proportion
- ✓ Use the colourway provided
- ✓ Place it on a background that displays it clearly.

The proportions of the mark's elements must remain consistent and must not be stretched or distorted in any way. No part of the mark can be cut, deleted, moved or replaced. The mark must stand alone and no wording must be added.

X Don't change the colour



X Don't place it where it can't be seen clearly



X Don't add text

## **Specifications**


## Sizing

The mark should never appear smaller than 20mm wide for print and 100 pixels wide for digital. If the mark is used too small, its quality and impact will be lost.

### Spacing

To give the mark sufficient space, we recommend allowing at least the amount shown around it's elements, as seen in this diagram.

These specifications apply to all our registrations for the bee mark.







## **Key colours**

The main colours used in the bee mark are taken from the Manchester City Council brand.





### **Prohibited uses**

Manchester City Council has ultimate and absolute discretion as to whether to permit or prohibit use of the mark. Use of the trade mark is prohibited for the following categories:

- faith, religion and equivalent systems of belief
- adult products and services
- alcohol, tobacco and gambling products
- weapons and gun clubs
- political or lobby groups
- any other categories that do not support the values and principles of the Manchester worker bee trade mark.



These guidelines will be periodically reviewed by Manchester City Council's Communications Service.
